**LEASE OF LAND AND CONSTRUCTION OF TOMBSTONE / HEADSTONE**

- The size of the tombstone / headstone shall not exceed  
 Thickness - 3 inches  
 Width - 2 feet  
 Height - 3 feet
- The approved registration number must be engraved / embedded on the tombstone / headstone and must be clearly visible.
- No fencing or planting of trees is allowed around the tombstone / headstone. The Board encourages offerings of fruits and flowers only at the tombstone.
- The land for construction of the tombstone / headstone is leased for a period of 30 years from the date of payment of **RM 2,500.00**. Upon expiry the lease must be renewed and the lease shall be for the next **30 years**. The payment for the lease shall be paid by way of **CASH ONLY**.
- Cost of the construction of the tombstone / headstone will be as follows:-
